Current Activities Report

AGM 7 June 2009

Scottish Parliament and Government

SCoJeC continues to monitor activity in the Scottish Parliament and Scottish Government on a daily basis. We forward relevant information to a wide range of Scottish communal organisations including Jewish Care, Cosgrove Care, Calderwood Lodge, Calderwood Jewish Education and the students, and to UK bodies including the Board of Deputies, CST, the “Antisemitism Coordinating Unit”, Shechitah UK, and other interested bodies, and we also brief them as necessary on, for example, relevant parliamentary procedures.

We also continue to brief MSPs on issues concerning the Jewish community, and, where appropriate, put them in touch with other organisations, such as the Care organisations, the Glasgow Jewish Representative Council, and the Israel Information Office, which have been able to provide information on specific issues.

Security

a) SCoJeC, together with the CST, met the Scottish Government and Police at the Scottish Government’s request to discuss the current increase in antisemitic activity. They were evidently shocked by the nature of recent incidents, and expressed concern that vulnerable members of the community, especially students and those in rural areas, now feel under threat, and undertook to draw the attention of relevant local authorities and police forces to increased needs of the community.

Post Mortems

We have had a number of informal discussions with the Lord Advocate, the Cabinet Secretary for Justice, the Procurator Fiscal service, MSPs, and health professionals, with a view to introducing MRI scanning as an acceptable alternative to surgical post mortem. This has been very successful in the Manchester area where the number of surgical post mortems in the Jewish community has fallen from around sixty to around three a year, and we have also been in discussion with relevant members of the Manchester Jewish community, and with local coroners who are very supportive of the scheme (which Jack Straw has announced that he hopes to extend throughout England and Wales). Our initial approaches have been very favourably received, and we are discussing with the Scottish Government how best to progress the matter.

Census

At the request of the Scottish Government, SCoJeC attended a meeting with the Registrar General and the Equality Unit to discuss Scottish Government proposals for ethnicity classifications to be used in the 2011 census. We are not alone in remaining dissatisfied with the decision to use classifications that were found wanting

by their own research, and will press the point with the Parliamentary committee which will make the final decision.

Disclosure

a) SCoJeC is represented on one of the Scottish Government consultative groups advising on the secondary legislation for the Protection of Vulnerable Groups Act, which will make wide-reaching changes to the "Disclosure" system for people working with children and vulnerable (or "protected") adults, and was also a member of a Scottish Government short-term working group advising on new guidance for the current Disclosure system.

b) SCoJeC raised a number of issues with the Minister for Children and Early Years about new secondary legislation for Disclosure. As a result, all of these issues have been explicitly addressed in the associated Guidance document.

Circumcision

SCoJeC was invited to participate in a meeting between the Cabinet Secretary for Health, Nicola Sturgeon, Bashir Ahmad MSP, and representatives of the Muslim community, to explain how the Jewish community provides for brit milah and the role of the Initiation Society.

CST antisemitism statistics

At the request of the CST, SCoJeC circulated the mid-year antisemitism statistics to MSPs, the Scottish Parliament Information Centre, and the Scottish Government Equality Unit. Several MSPs requested information about Scotland-specific figures that were provided by CST and SCoJeC.

Time for Reflection

In response to a request from the Presiding Officer's office, SCoJeC recommended Rabbi Nancy Morris as an appropriate Jewish speaker at "Time for Reflection". In consequence of that advice, Rabbi Morris addressed the Scottish Parliament on 25 June 2008.

Faith Liaison Group

SCoJeC is represented on the Scottish Executive Faith Liaison Group (FLaG) which enables policy civil servants from all Executive departments to consult representatives of faith communities on proposed initiatives.

Consultation Responses

Scotland Office

SCoJeC arranged a meeting at Garnethill Synagogue between the Secretary of State for Scotland and the leaders of the various Scottish Jewish communities and communal organisations. The meeting also included a tour of the newly refurbished Archive Centre.

SCoJeC was invited by the Secretary of State to a small meeting at the Scotland Office to discuss the effect of the economic crisis on faith communities. Also present were Archbishop Conti, Ian Galloway (Convener, Church of Scotland Church and Society Council), and Shafi Kausar (Glasgow Central Mosque).

At the initiative of the Scottish Secretary, SCoJeC is a signatory to a Scotland Office statement recognising that a low turnout in the European Parliament elections may benefit extremist parties, and supporting an initiative to encourage voter registration and participation in the ballot.

Other organisations

Disclosure Scotland

SCoJeC continues to act as a Registered Body with the CRBS (Central Registered Body in Scotland) to enable communal organisations to meet the requirements of the Protection of Children (Scotland) Act. We also, at their request, administer Disclosure applications for the Scottish Interfaith Council, BEMIS, and the Scottish-Iranian Association.

We attend regular meetings with the CRBS and the Scottish Churches Committee Child Protection Group to discuss issues around Disclosure and to share information and expertise.

UK Border Agency

SCoJeC has registered as a sponsor in order to assist communal organisations that wish to employ individuals (paid or as a volunteer) from outwith the European Economic Area. There is no other route by which such individuals can enter the UK – even a rabbi who comes to Scotland to officiate at a single wedding must qualify under this scheme in order to obtain a visa. This is a significant service to communal organisations, who would otherwise have to register separately, with associated costs and other risks. We have already discovered how complex the new system is, but we trust that as we gain expertise, we will be able to advise and assist organisations to obtain visas for foreign workers.

Jewish Leadership Council: Political Affairs Brief

A consortium that includes the Board of Deputies and the Jewish Leadership Council has commissioned SCoJeC to produce a daily digest of political matters affecting the Jewish community. This covers activity in the UK and Scottish Parliaments and

Governments, the Welsh Assembly and Assembly Government, and the Northern Ireland Assembly and Executive.

Church of Scotland

SCoJeC continues to hold regular meetings with the Church and Society Council of the Church of Scotland, and also had a formal meeting with the last Moderator and the Principal Clerk, both of whom also participated in last summer's Interfaith Pilgrimage.

STUC

SCoJeC has held a number of bilateral meetings with the STUC to discuss matters of mutual concern, and once again contributed a short message to its annual anti-racism brochure. We held a special meeting to discuss the report of their delegation to Israel and Palestine, and its proposal for "Boycott, Disinvestment, and Sanctions", and were very disappointed that the proposal was adopted by Congress without dissent. We have made clear to the STUC that while we do not believe they are motivated by any personal antisemitic prejudice, they have failed to take account of the effect of their policy on members of the Jewish Community.

BEMIS

SCoJeC's director, Ephraim Borowski, is also Vice-Convener of BEMIS (the Scottish ethnic minority umbrella organisation), and we welcome continued collaboration on projects such as the Interfaith Pilgrimage, and MEMO and MEMO+. (*see below*)

Externally Funded Projects

Outreach

Leaflets and posters have been distributed to all libraries in Scotland, and we have responded to subsequent e-mails and phonecalls from isolated Jewish individuals wanting contact with the Jewish community. All of these have been sent back-issues of *Four Corners*, added to the mailing list for future issues, and, where possible, have been put in touch with other local Jewish people.

We have also written to communal organisations inviting them to bid for a share of our grant funding for collaborative projects that will reach out to isolated individuals outside the mainstream community. Several applications have been received and a decision will be made shortly after the AGM, with a view to projects commencing in the autumn.

Scotland's Jews

Scotland's Jews, which was launched by the then Communities Minister, Stewart Maxwell, after last year's AGM, has now been distributed to all MSPs and all public libraries and schools in Scotland, and we are about to begin distribution to independent schools, the NHS and Police.

Interfaith pilgrimage

The interfaith pilgrimage to Israel was organised as part of an initiative to increase understanding and friendship between communities in Scotland. The idea grew out of a conversation between SCoJeC Director Ephraim Borowski, and Rami Ousta, CEO of BEMIS, the umbrella organisation for minority community organisations in Scotland, who were concerned that tensions in the Middle East may sometimes be an obstacle to the development of good relations locally. The Very Reverend Dr Finlay Macdonald, principal clerk and former Moderator of the Church of Scotland, and Na'eem Raza, Director of Meem, a diversity training organisation, both joined the steering group, and around thirty people from seven different faith communities were invited to participate in the trip, which took place at the beginning of July.

We received very positive feedback about the pilgrimage both from participants and from people who either met the group in Israel or else read about it online (see http://www.scojec.org/events/2008/08vii_pilgrimage/menu.html) or in the media. In addition to the informal feedback of pilgrims' "reflections" we carried out an online survey in order to gather more formal feedback for a report to funders and to provide information for planning future trips. Participants expressed extremely positive views about the pilgrimage, and are keen to use their experiences to promote good community relations in Scotland. Many have given talks or held meetings about it either with members of their own or other communities, and a question-time panel, organised jointly with GJRC, took place in March. This was chaired by Lesley Riddoch and recorded for broadcast by BBC Scotland.

However, following the failure of an attempt by the Scottish Palestine Solidarity Campaign to have Christian participants boycott the Pilgrimage, which they described, in advance of any information about the itinerary as "cynical Zionist propaganda", Mick Napier published a lengthy, and extremely vitriolic condemnation of the pilgrimage on the Scottish Palestine Solidarity Campaign website, in which he criticises several participants by name both personally and for their diary entries and reflections which were published on the SCoJeC website. In particular he refers to Fiona and Howard Brodie as "the features of hardened Zionism", and uses "Jews" and "Israelis" interchangeably.

MEMO and MEMO+ (Minority Ethnic Matters Overview)

We continue to receive very positive feedback about MEMO, the weekly bulletin of information relevant to minority ethnic communities in Scotland, which is compiled in response to a request from BEMIS. MEMO includes information about relevant activity in the Scottish and Westminster Parliaments, the Scottish Government and Whitehall, organisations such as the NHS, Equalities and Human Rights Coalition, as well as details of relevant consultations and new publications.

MEMO+ is an occasional publication that provides more in-depth information about particular issues, such as this week's European Parliament elections.

Four Corners

Four Corners continues to be very well-received. The majority of paper copies are sent to people living in the smaller Jewish communities or outwith any Jewish community, but it also has a large online readership.

Other Activities

Supporting individuals and communities

SCoJeC liaised with the CST, police, Jewish communities, and individuals in relation to security and antisemitic incidents resulting from the situation in Gaza. In particular, we provided a listening ear and reassurance for people from the smaller communities and isolated individuals in rural areas who have been victims of antisemitic incidents, or who are apprehensive that they may be.

In collaboration with the Chaplaincy, SCoJeC also provided support and information for students responding to campus “occupations”, boycott motions, etc.

Public Resource

Website (www.scojec.org)

The website continues to be extremely well-used, with around 1500 unique visitors each month, viewing a total of around 16 500 pages. The "Guide to Jewish Facilities in Scotland" is particularly popular, as are *Scotland's Jews*, *Four Corners*, and MEMO.
