Immigration and Asylum

Scottish Parliament Written Answers

Non-UK nationals: right to vote

Alex Cole-Hamilton (Liberal Democrat) [S5W-13349] To ask the Scottish Government what its position is on non-UK EU nationals continuing to have the right to vote in (a) local authority and (b) Scottish parliamentary elections post-Brexit.

Reply from Joe FitzPatrick: The Scottish Government has full responsibility for the franchise for both local government elections and also elections to the Scottish Parliament. In both elections, the franchise includes people resident in Scotland who are:

- British Citizens; or
- Qualifying Commonwealth Citizens; or
- Citizens of the European Union.

Therefore, at present, non-UK EU nationals have the right to vote in Scottish elections and the Scottish Government intends that this will continue to be the

position in future.

On 19 December 2017, the Scottish Government launched a public consultation on Electoral Reform. The consultation includes discussion around a proposal to further extend the franchise in Scottish elections to include everyone legally resident in Scotland. The consultation will run for 12 weeks until 12 March 2018.

Asylum seekers: antenatal classes

Anas Sarwar (Labour) [S5W-13334] To ask the Scottish Government what information it has on how many asylum seekers accessed antenatal classes in each of the last three years.

Reply from Aileen Campbell: This information is not held centrally.

The Scottish Government have worked with NHS Boards to improve early access to antenatal services and have created a Local Delivery Plan Standard to help drive improvement. The standard states that at least 80% of pregnant women in each deprivation area will have booked for antenatal care by the 12th week of pregnancy.

Information Services Division (ISD), part of NHS National Services Scotland, published The Births in Scottish Hospitals report on 28 November. This report showed that the Antenatal Access standard had been met at a Scottish level across all deprivation categories.

Scotland's approach to integration aims to provide a positive experience for refugees and asylum seekers and enable them to rebuild their lives here, through access to the support and services they need, including health care services.

Immigration

The following two questions both received the same answer

Ged Killen (Labour Co-op) [119832] To ask the Secretary of State for the Home Department, how many meetings she has had with Scottish Government Ministers on the Government's proposed reforms to the UK's immigration system after the UK leaves the EU.

Immigration: Scotland

Ged Killen (Labour Co-op) [119834] To ask the Secretary of State for the Home Department, which Scottish business sectors have made representations to her on immigration schemes for Scotland after the UK leaves the EU.

Reply from Brandon Lewis: The Government is considering a range of options for the immigration system for EU citizens after the UK leaves the EU. Since the Referendum result last year, Ministers have been undertaking an extensive programme of engagement and evidence gathering with all interested parties including the Devolved Administrations, businesses, educational institutions and many others. Most recently, I discussed the recent agreement on citizens' rights

and next steps on the future immigration arrangements at the Joint Ministerial Committee (European Negotiations) on 12 December 2017. Home Office officials also have frequent meetings with their colleagues in the Devolved Administrations, including the Scottish Government.

On 27 July, the Government commissioned the independent Migration Advisory Committee to advise on current patterns of EU migration across all sectors, and the role of migration in the wider economy and society. This will be an important element in our decisions about future immigration arrangements that work for all parts of the UK.

Immigration

Ged Killen (Labour Co-op) [119833] To ask the Secretary of State for the Home Department, whether her Department has made an assessment of the potential merits of reforming the immigration system with a view to increasing working age populations in regions where growth in that demographic has halted or is in decline; and if she will make a statement.

Reply from Brandon Lewis: There is a wide range of options as to how EU migration might work we leave the EU. We are considering these options very carefully and we will take decisions based on evidence. As part of this, on 27 July, the Government commissioned the Migration Advisory Committee (MAC) to gather evidence on patterns of EU migration and the role of migration in the wider economy, ahead of our exit from the EU. We have asked the MAC to report by September 2018 and flagged that interim reports throughout the period would be helpful as we develop future immigration arrangements that work for the whole of the UK.

Immigration remains a reserved matter and we will consider the needs of the UK as a whole. Applying different immigration rules to different parts of the UK would complicate the immigration system, harming its integrity, and cause difficulties for employers who need the flexibility to deploy their staff to other parts of the UK.

The Government will be setting out initial proposals for our future immigration arrangements shortly.

Immigration

Rupa Huq (Labour) [120217] To ask the Secretary of State for the Home Department, what steps she is taking to ensure that those establishing residency in the UK via a Tier 1 visa pass strict checks.

Reply from Brandon Lewis: In 2015, we introduced new, more stringent measures on our Tier 1 (Investor) route before applicants can invest in the UK. These changes ensure that migrants are subjected to stronger due diligence and anti-money laundering checks before they are granted a visa. We also doubled the minimum required investment and removed a provision which allowed migrants to invest money which had been obtained through loans. We created new powers to refuse applications including where granting the visa is not conducive to the public good.

On the Tier 1 Entrepreneur route, we have introduced a number of measures which ensure that migrants must demonstrate that they have made an economic contribution to the UK before they can settle.

Immigration

The following two questions both received the same answer

Ben Lake (Plaid Cymru) [119586] To ask the Secretary of State for the Home Department, what assessment she has made of the potential merits of allowing non-EEA nationals who were granted permanent residency under EEA Regulations but who are no longer family members of EEA nationals to switch to settled status.

Ben Lake (Plaid Cymru) [119588] To ask the Secretary of State for the Home Department, what steps she is taking to ensure that non-EEA nationals who were granted permanent residency but who are no longer family members of EEA nationals can obtain settled status when the UK leaves the EU.

Reply from Brandon Lewis: The UK and European Commission agreement set out in the Joint Report published on 8 December 2017 protects EU and UK citizens and their family members who have exercised free movement rights by the time of the UK's withdrawal from the EU. Under the Free Movement Directive (2004/38/EC), once acquired, permanent residence is held on an individual basis and as such those who have been granted that status on the basis of their relationship with an EU citizen do not lose it if they cease to be a family member. Provided they are legally resident at the time of the UK's withdrawal, such persons will be eligible to apply for settled status.

The Government has been clear that we want to secure the same protections for non-EU EEA nationals (citizens of Norway, Iceland and Liechtenstein) and Swiss nationals as soon as possible, on a reciprocal basis.

Migrant Workers: EU Nationals

Stephen Timms (Labour) [118831] To ask the Secretary of State for the Home Department, whether she plans to implement a communications campaign to make it clear to EU workers in the UK that they will be able to obtain settled status.

Reply from Brandon Lewis: The Home Office is already communicating about the settled status scheme for EU citizens and their families through the media, digital channels and with stakeholders, including businesses and EU citizens' representatives. Communication activity will increase next year towards the launch of the scheme in late 2018, and throughout the two-year 'grace period' for EU citizens and their family members to obtain settled status.

Mental Health Services: Refugees

Barbara Keeley (Labour) [118387] To ask the Secretary of State for Communities and Local Government, what steps his Department is taking to support local authority provision of mental health services for child refugees.

Reply from Marcus Jones: Health services are the responsibility of the Department of Health. Child refugees are entitled to the same rights as other looked-after children and young people, including access to National Health Service (NHS) mental health services. The NHS actively seeks to meet the unique needs of a wide range of vulnerable groups, including asylum seekers of all ages, and local NHS services have legal duties to meet the varied needs of their population. Access to Mental Health services is based on clinical need. To improve the offer to all children, the Government published The Children and Young People's Mental Health Green Paper on 4 December. This sets out an ambitious set of proposals to transform support for children and young people's mental health generally.

Refugee resettlement programmes can also provide an avenue towards mental healthcare. Under resettlement programmes, Clinical Commissioning Groups (CCGs) and Local Health Boards can claim a per capita amount for primary and secondary healthcare costs – including mental health costs – for refugees they support. If per capita costs are exhausted, CCGs and Local Health Boards can claim additional funding for secondary healthcare costs identified during the first 12 months of a refugee's arrival. Funding decisions do not rest with the Department for Communities and Local Government but with the Home Office, which is accountable for the Resettlement Programme.

Local authorities have been invited to bid for funds to assist their capacity to support unaccompanied asylum-seeking children (UASC) through the Controlling Migration Fund. The Department for Communities and Local Government manages part of this fund, and bids have included interventions to support UASC mental health. The bidding opportunity has closed and we will be announcing the results of this programme early in the New Year.

Reply from Alistair Burt: The UK promotes the safe, voluntary and dignified return home of refugees and IDPs. DFID is supporting the rehabilitation of priority infrastructure such as schools, hospitals and water treatment plants in areas liberated from Daesh in Iraq, and facilitating planning for regional returns in the major refugee hosting countries neighbouring Syria.

Asylum: Housing

Barry Sheerman (Labour Co-op) [120280] To ask the Secretary of State for the Home Department, if he will take steps to ensure that future asylum accommodation contracts work to ensure the long-term sustainability of the dispersal system through co-operative working with local authorities and communities.

Reply from Brandon Lewis: The Home Office is committed to working co-operatively with local authorities and communities to ensure the sustainability of asylum accommodation contracts.

Since September 2016 the Home Office has actively engaged with local authorities with a wide range of stakeholders across local government, statutory and third sector as part of the development of the new asylum accommodation contracts and the information obtained through this process has influenced the design of the future service provision. We will continue to engage with local authorities and the wider community throughout the procurement and implementation of the new contracts.

Deportation: EU Nationals

Tim Loughton (Conservative) [119645] To ask the Secretary of State for the Home Department, how many non-UK EU citizens have been deported to their home country in each of the last 10 years.

Reply from Brandon Lewis: The number of enforced returns by country of nationality is published in table rt_04 (Volume 3 - Returns data tables where returns are broken down by country of nationality and the destination to which an individual is returned to) in 'Immigration Statistics, July - September 2017', available from the Home Office website at:

The term 'deportations' refers to a legal definition of a specific set of returns. Deportations are a specific subset of returns which are enforced either following a criminal conviction or when it is judged that a person's removal from the UK is

conducive to the public good. The deportation order prohibits the person returning to the UK until such time as it may be revoked. Published information on those deported is not separately available. As such, the question has been interpreted as referring to enforced returns. In an enforced return, it has been established that a person has breached UK immigration laws and / or has no valid leave to remain in the UK. They have declined to leave voluntarily and the Home Office enforces their departure from the UK.

Immigrants: Detainees

The following two questions both received the same answer

Gareth Thomas (Labour Co-op) [119960] To ask the Secretary of State for the Home Department, if the Government will take steps to ensure that all persons detained under immigration powers who claim to be stateless or whose nationality is unclear or disputed are advised in a language they understand of the possibility of applying to remain in the UK as a stateless person under Part 14 of the Immigration Rules.

Gareth Thomas (Labour Co-op) [119961] To ask the Secretary of State for the Home Department, if the Government will take steps to ensure that all persons detained under immigration powers who claim to be stateless or whose nationality is unclear or disputed can access free legal (a) advice on their eligibility to make an application under Part 14 of the Immigration Rules and (b) assistance to make such an application where there is merit in so doing.

Reply from Brandon Lewis: The Home Office does not detain those who are stateless who cannot be removed to any other country.

We will only detain persons where they can be removed within a reasonable timeframe and issues regarding statelessness or nationality disputes are considered in assessing whether detention is appropriate.

The Government has no plans to provide detainees with advice on the possibility of applying to remain in the UK as a stateless person because those in detention are considered to be removable and as such admissible to another country for purposes of residence there. All detainees are made aware of their right to legal representation, and how they can obtain such representation, within 24 hours of their arrival at an immigration removal centre (IRC). The Legal Aid Agency operates legal advice surgeries across the detention estate in England, with detainees receiving up to 30 minutes of advice without reference to financial eligibility or merits of their case. There is no restriction on the number of surgeries a detainee may attend. If a detainee requires substantive advice on a matter which is in scope of legal aid then full legal advice can be provided.

Detainees also have regulated access to the internet under the requirements set out in Detention Services Order DSO 04/2016 (Internet access). This enables them to independently identify contact details for immigration legal advisors and to make an application for Stateless Leave. Legal reference material is stocked in all IRC libraries and each IRC has a welfare officer who can signpost detainees to information on how to access legal advice.

Immigrants: Detainees

Gareth Thomas (Labour Co-op) [119973] To ask the Secretary of State for the Home Department, if the Government will place a time limit of 28 days on immigration detention.

Reply from Brandon Lewis: The Government has no plans to introduce a fixed time limit on immigration detention as this would only encourage detainees to refuse to cooperate with immigration and asylum processes until they reached the point at which they had to be released from detention and thus avoid their enforced removal from the UK. Published Home Office policy is clear, however, that detention is only used for the shortest period necessary.

Human Trafficking: Migrant Workers

Vernon Coaker (Labour) [119769] To ask the Secretary of State for the Home Department, what assessment she has made of the effectiveness of her Department's procedures for identifying the exploitation and human trafficking of undocumented non-EEA nationals working in the UK fishing industry; and if she will make a statement.

Reply from Victoria Atkins: The Government has introduced mandatory training for Border Force and UKVI staff to identify at risk seafarers from outside the EEA who enter the UK in order to join a vessel departing from a UK port. They are advised of their rights before they board vessels and any suspicious circumstances in relation to vessels and contracts are investigated further.

The Government also introduced specific maritime provisions in the Modern Slavery Act 2015 to provide powers to law enforcement agencies to tackle suspected slavery at sea and have provided significant additional funding to the police to improve the wider operational response to modern slavery. This funding includes provision for a dedicated ports and transport officer to provide tactical advice on all aspects of slavery and exploitation occurring in the maritime arena.

We keep the effectiveness of these measures under review, and will consider whether checks on those coming to join UK-based fishing vessels should be adjusted to reflect the ILO Work in Fishing Convention 2007 (ILO 188) which sets out minimum living and working conditions for fishermen.

Teachers: Migrant Workers

Lord Browne of Belmont (DUP) [HL4191] To ask Her Majesty's Government how many teachers from overseas have been awarded qualified teacher status in the UK in each of the last three years, broken down by country.

Reply from Lord Agnew of Oulton: The Department for Education produces statistics for England only. The responsibility for education statistics in Northern Ireland, Scotland and Wales lies with each devolved administration.

The attached tables provide the number of qualified teachers from overseas who have been awarded qualified teacher status (QTS) in England in each of the last three years available (financial year 2014/15 to financial year 2016/17). These tables are taken from published statistics in the initial teacher training (ITT) census, available at the department's ITT Statistics webpage.

Table 8, attached, shows the number of QTS awards made in England to qualified teachers from the European Economic Area (EEA) under EU Directive 2005/36/EC.

Table 8a, attached, shows the number of QTS awards made in England to qualified teachers from overseas (excluding the EEA).

Refugees: English Language

The following two questions both received the same answer

Lord Alton of Liverpool (Crossbench) [HL4127] To ask Her Majesty's Government what progress has been made in improving English language provision for refugees since the meeting between Home Office Ministers and Lord Alton of Liverpool on 21 November; and whether they have any plans to provide more fast track English language training to enable Syrian refugees, and other suitably qualified doctors, nurses, and other medical professionals, who are refugees, to take up work in the NHS.

Lord Alton of Liverpool (Crossbench) [HL4128] To ask Her Majesty's Government whether they intend to change rules that impact the ability of refugees who are health professionals to access full time English language lessons while being in receipt of jobseeker's allowance.

Reply from Baroness Williams of Trafford: As soon as adults are granted refugee status or humanitarian protection they become eligible for skills funding (including for ESOL courses) through the adult education budget.

The Home Office also provides funding for English language as part of its commitment to resettling vulnerable people through the Vulnerable Persons Relocation Scheme to the UK. This funding includes a tariff for each person resettled, a proportion of which can be allocated to ESOL provision. For those resettled under these programmes, local authorities are now required to provide a minimum of eight hours' formal tuition a week, within a month of arrival, and for a period of at least 12 months, or until the individual reaches at least English for Speakers of Other Languages (ESOL) entry level three (whichever is the sooner).

All NHS professions (including all doctors and nurses) have an English language requirement of IELTS 7. This is not a Home Office requirement but a requirement set by their regulatory bodies (for example General Medical Council). ESOL courses are available for free to those in receipt of jobseeker's allowance.

 Under our existing family reunion policy, we have granted over 24,000 visas to nuclear family members of refugees in the last five years. We therefore believe that the impact of the Bill would increase the costs to the public purse significantly because it would widen the definition of a family member of a refugee and enable a large number of extended family members to qualify to come to the UK and have access to public services. The Government's priority is to provide international protection to people who need it and extending the scope of family reunion to extended family members who may themselves not need international protection would not achieve that.

Individuals who require protection because of their sexual orientation are likely to be referred to us under UNCHR's vulnerability category of 'Legal and/or Physical Protection Needs'. We have no plans to change this approach.

Lord Scriven (Liberal Democrat) [HL4326] To ask Her Majesty's Government what steps have been taken to intensify outreach to LGBT refugees who may be in need of resettlement under the Vulnerable Persons Resettlement Scheme.

Reply from Baroness Williams of Trafford: In all of the countries from which we resettle refugees fleeing the Syrian conflict, the United Nations High Commissioner for Refugees (UNHCR) has undertaken significant efforts to ensure that LGBTI individuals are able to register. These include establishing mobile registration units, outreach teams and help desks for areas where different minority groups are concentrated. This is all part of an effort to facilitate registration for those refugees who, for whatever reason, cannot or choose not to access the main registration offices.

In addition to training its staff on LGBTI issues, UNHCR also works closely with partner non-governmental organisations (NGOs) supporting the LGBTI community in the region to facilitate registration, ensure access to services and explore available durable solutions, which may include consideration for resettlement. The NGOs have autonomy to refer such cases to UNHCR where particular protection concerns exist.

Ethnicity Pay Gap

S5W-13040 Jackie Baillie (Labour): To ask the Scottish Government, further to the answer to question S5W-10398 by Jamie Hepburn on 10 August 2017, whether it has made or plans a further assessment of the need for new statistical outputs regarding the ethnicity pay gap.

Reply from Jamie Hepburn: The Scottish Government has provisionally calculated the ethnicity pay gap using the Annual Population Survey data source. The estimate produced is now being quality assured by Scottish Government analysts in liaison with the Office for National Statistics, who own the data, to assess whether this Scottish estimate is reliable for public use.

We are also exploring whether a more reliable estimate may be produced from the three year pooled Annual Population Survey data set 2014-2016. Following our review these estimates will be made available on the Scottish Government web site, alongside technical notes and guidance.

Faith Schools: Teachers

Chris Williamson (Labour) [118775] To ask the Secretary of State for Education, whether a voluntary-aided English school designated with a religious character can give preference on the grounds of religion in connection with the appointment of every single one of its teachers.

Reply from Anne Milton: A voluntary aided English school designated with a religious character is permitted to take faith into account when appointing employing teachers - see section 60 of the School Standards and Framework Act 1998.

This provision does potentially apply to the appointment of all teachers at such a school but it does not provide blanket protection or an unlimited exception from the terms of the Equality Act 2010 and is not a licence to discriminate on the basis of religion or belief. If challenged as to the use of section 60 in a particular case, a school would be expected to justify the use of the power in the relevant context, the justification being that it was legitimate to take faith into account in the particular case or context. For example, a school might rely on factors such as the pastoral responsibilities of all teachers, regardless of subject or seniority, and the importance that such pastoral responsibilities are discharged consistently by the teachers in the school.

Also, it is our expectation that schools with a religious character will balance the need to maintain the religious character of their school with that of securing the best staff for their school.

Reply from Jeremy Wright: The Crown Prosecution Service (CPS) maintains a central record of the number of defendants flagged as committing hate crime offences that were prosecuted and convicted through its Case Management System.

The table below shows the volume and proportion of hate crime prosecutions and convictions during each of the last three years.

Religious Hatred: Islam

Martyn Day (SNP) [114985] To ask the Secretary of State for Communities and Local Government, what assessment he has made of the implications for his Department's policies of the conclusions of the Tell MAMA Annual Report for 2016 on Anti-Muslim Hatred on the gender of victims and the majority identity of perpetrators of such hatred.

Reply from Marcus Jones: We take hate crime in all its forms very seriously: the United Kingdom has some of the strongest hate crime legislation in the world. The statistical breakdowns provided by Tell MAMA give an invaluable insight into the extent and nature of the deplorable abuse which Muslim citizens are subjected to

on account of their belief or appearance. It is notable that most reported offline incidents of anti-Muslim hatred involve male perpetrators and that the majority of victims of offline incidents are women, most of whom are visibly Muslim. The Government has committed funding of £100 million to counter violence against women and girls with prosecutions and convictions for such offences rising 63 per cent since 2007-08.

This Government has done more than any other to tackle anti-Muslim hatred. We set up the first ever cross-government working group on anti-Muslim hatred. We have funded Tell MAMA, the first service to record incidents, support victims and raise community awareness of how to report anti-Muslim hate incidents. We are also disaggregating religious hate crime data held by the police to reveal the true scale and nature of the problem. Funding has been made available for the security of mosques and other faith establishments.

Religious Hatred: Prosecutions

Lord Pearson of Rannoch (UKIP) [HL4003] To ask Her Majesty's Government, further to the answer by Baroness Vere of Norbiton (HL Deb, col 1052) on 6 December, whether the Crown Prosecution Service's definition of hate crime includes any action or speech which is perceived by the victim or any other person to be motivated by prejudice based on a person's religion; and where such action or speech leads to a successful prosecution, what is the maximum sentence.

Reply from Lord Keen of Elie: The shared CPS and NPCC flagging definition of a religiously motivated hate crime covers any incident or crime which is perceived by the victim or any other person, to be motivated by hostility or prejudice based on a person's religion or perceived religion. In order for a crime to be charged and prosecuted as a hate crime, the CPS uses the legal definitions contained in the Crime and Disorder Act 1998 (CDA 1998) and the Criminal Justice Act 2003 (CJA 2003).

The CDA 1998 creates a number of specific racially or religiously aggravated offences, each of which has a higher maximum sentence than the 'basic' non-racially or religiously aggravated version of the offence. For other offences, the CJA 2003 places a duty on the courts to increase the sentence where the defendant has been convicted of an offence where they have demonstrated or been motivated by hostility towards the victim based upon their protected characteristic. The CDA 2003 does not set a maximum sentence. Sentencing is a matter for the courts and will depend on the individual circumstances of the case and the legislation under which the defendant has been convicted.

Religious Hatred: Prosecutions

Lord Pearson of Rannoch (UKIP) [HL4004] To ask Her Majesty's Government, further

to the answer by Baroness Vere of Norbiton (HL Deb, col 1052) on 6 December, whether the Crown Prosecution Service's definition of hate crime covers cases in which a Christian says that Jesus is the only Son of the one true God if this offends anyone of any other religion.

Reply from Lord Keen of Elie: The CPS assesses each case on its individual facts and circumstances. Prosecutions can only be brought in line with legislation and in accordance with the Code for Crown Prosecutors. For something to be considered a hate crime, the perpetrator must have first committed a crime in accordance with the relevant legislation.

The CPS legal guidance on hate crime recognises the right to freedom of expression set out in Article 10 of the European Convention on Human Rights. The CPS seeks to balance the right to freedom of speech and expression against the duty of the state to act proportionately.

In relation to offences of stirring up religious hatred, there is a freedom of expression defence contained in Section 29J of the Public Order Act 1986, which explicitly states nothing in the Act; "...prohibits or restricts discussion, criticism or expressions of antipathy, dislike, ridicule, insult, or abuse of particular religions, or the beliefs or practices of its adherents."

The draft bill does not affect the right of Jewish and Muslim communities to eat meat from animals slaughtered in accordance with religious rites. There are strict rules that govern the slaughter of animals in England and additional rules which apply to animals slaughtered in accordance with religious rites.
