## Scottish Parliament Oral Answer

### European Union Settlement Scheme

**Jenny Gilruth (SNP):** Today's report from the House of Commons Home Affairs Committee says that the United Kingdom's settlement scheme for EU citizens risks another Windrush scandal. Is that not a salutary warning that we should not be making EU citizens apply to remain in their homes? Have the Tories learned nothing from last week's election, when their hostility towards immigrants was roundly—and rightly—rejected?

**Reply from the First Minister (Nicola Sturgeon):** I think that, from most of what the Tories have had to say in the past few days, they—certainly the Scottish Tories—have learned nothing at all from the fact that they have been pushed into fourth place in Scotland in the elections. They should carry on. The longer that they fail to learn those lessons, the better it is for those of us on the Scottish National Party benches.

Jenny Gilruth raises a serious issue. Windrush was a scandal—even the Tories would concede that. What European nationals are being put through—they are having to apply for the right to continue to live here in their own country—is shocking, and it risks repeating that scandal. They should not be being put in that situation. This is their home and they should be able to stay here. We should all continue to argue against those measures and send the clearest possible message that those who choose to make this country their home are welcome here and we want them to stay.

**Stephen Morgan (Labour)** [257070] To ask the Secretary of State for the Home Department, how many people who secured indefinite leave to remain in the last 12 months (a) obtained legal advice and (b) did not obtain legal advice on their applications.

**Reply from Caroline Nokes:** Information on the number of applicants who were granted with Indefinite Leave to Remain (ILR) who obtained legal advice as part of their application is not collated centrally as part of the production of the quarterly Immigration Statistics.

**Chuka Umunna (Change UK)** [256324] To ask the Secretary of State for the Home Department, what steps his Department takes to safeguard visa applicants from stress and other mental health problems which occur as a result of delayed decisions and other complications in the application process.

**Reply from Caroline Nokes:** Comprehensive guidance is published on GOV.UK on the visa application process. This includes information regarding our Customer Service Standards (CSS) timescales for processing visa applications.

If an application is complex or delayed for any reason, Visas & Citizenship staff contact the applicant and inform them if it is anticipated that the CSS will not be met. Applicants can contact V&C should the need arise. Contact details are published on the GOV.UK website here:

**Reply from Caroline Nokes:** The Home Office is unable to report on how many women detained for immigration purposes disclosed experience of domestic abuse, as such detail is recorded on individual Home Office files and to obtain this information would require a manual trawl and could only be obtained at disproportionate cost.

**Reply from Caroline Nokes:** Whilst the Home Office holds data on the number of individuals referred to Immigration Enforcement by the Police, it does not set out detail of the referral in a reportable manner or how such individuals came to the attention of the Police in the first instance. We are therefore unable to say how many individuals have been referred to Immigration Enforcement as a result of reporting a crime to the Police.

### Scottish Parliament Motion

**S5M-17454 Fulton MacGregor (SNP): Report by Close the Gap** – That the Parliament welcomes the recent launch of the Close the Gap report, *Still Not Visible: Black and minority ethnic women's experiences of employment in Scotland*; recognises that this new research aims to deliver information, statistics and experiences of the inequalities that BME women face in Scotland; notes with concern findings in the report, which show that almost three-quarters of BME women in the workplace have experienced racism, discrimination, racial prejudice and bias, while 42% indicated they had experienced bullying, harassment or victimisation, simply because they were a BME woman; understands that further evidence in the report highlights problems with workplace reporting mechanisms, with over half of the victims choosing not to report a complaint, and with less than a quarter feeling satisfied with how their complaint was handled; considers that this report provides strong evidence that BME women continue to face high levels of racism, racial prejudice and discrimination in the labour market; considers that tackling BME women's labour market inequalities, particularly where there is also wealth- and poverty-related inequality, is a necessary step if Scotland is to realise its ambition for inclusive growth; further considers that this requires transformational change, with policymakers and employers adopting intersectional approaches and targeted solutions, and congratulates Close the Gap on producing this report in the fight to reduce inequality for women from a BME background in the labour market.

### Ministerial Statement

#### Next Steps in Scotland's Future

**The Cabinet Secretary for Government Business and Constitutional Relations (Michael Russell):** Much has happened since late April, when the First Minister set out the Scottish Government's view of the continuing Brexit chaos and of the measures that this Government must bring forward to protect the people of this country.

Last Thursday, Scotland said, loudly and clearly, that it is a European nation and it intends to remain one. It also rejected all attempts to deflect that argument with spurious assertions about other matters and showed its contempt for equivocation. ...

On 11 April, when the European Union threw the United Kingdom a lifeline so that it could avoid a no-deal Brexit, Donald Tusk, the President of the European Council, said to Westminster: "Please do not waste this time".

He has been ignored. Not only has nothing happened to resolve the Brexit impasse, the stalemate looks like lasting for several more months whilst ever more extreme Tory members of Parliament vie with each other to present the most hard-line positions to their party faithful. ...

So let me at the outset make one thing very clear to the Tories at Westminster and the Tories in this chamber. The Scottish National Party manifesto on which we won the Holyrood election in 2016, and on which this Government is founded, said that the Scottish Parliament should have the right to hold another referendum "if there is a significant and material change in the circumstances that prevailed in 2014, such as Scotland being taken out of the EU against our will."

Any deal that takes Scotland out of the EU against the wishes of the majority of people in Scotland has that effect. ...

If a new Tory prime minister attempts a no-deal Brexit, although we will do everything possible to stop it, and everything we can to mitigate it, it will be yet further proof that the

conditions set out in our manifesto in April 2016 have been met in full, and there will be even greater urgency to give Scotland the choice of a different future. ...

I can confirm that despite the chaos that we witness in Whitehall, my colleagues and I will continue to attend intergovernmental meetings with UK and Welsh—and hopefully soon Northern Irish—counterparts. The destination that the Scottish Government wishes for this country is independence, but as we travel towards that, we have a role in helping to improve the structures under which we presently live and work. ...

Let us now turn to the destination and the three areas of activity that the First Minister set out in her April statement.

First, the Referendums (Scotland) Bill was introduced to the Parliament yesterday and has been published this morning. It is hoped that the bill will have completed its parliamentary progress by the end of this calendar year. As the First Minister said in April, it is the intention of the Scottish Government to offer the people of Scotland a choice on independence later in the term of this Parliament. Of course, should circumstances change, we would have the option of seeking Parliament's agreement to proceed on an accelerated timetable. ...

As the First Minister indicated in her statement, at a future date, we intend to negotiate with the UK Government for a section 30 order to put beyond doubt our competence to hold a referendum on independence. ...

The proposed franchise will be based on that used for local government and Scottish Parliament elections, which includes EU citizens and 16 and 17-year-olds. ...

Finally, we have made considerable progress on the creation of a citizens assembly. ...

There is already a lot of interest in and enthusiasm for the assembly. I hope that all parties will welcome and become involved in the initiative ...

**Gillian Martin (SNP):** How will proposed legislation on female genital mutilation increase protection for women and girls?

**Reply from the First Minister (Nicola Sturgeon):** I thank Gillian Martin for raising that issue. I am very pleased that we have now introduced the Female Genital Mutilation (Protection and Guidance) (Scotland) Bill, which will increase the protections for women and girls. The new legislation is an important step in the Government's efforts to make Scotland equally safe for women and girls. It will create a new protection order to protect women and girls who may be victims of, or at risk of, FGM and will ensure that ministers issue statutory guidance to public bodies to improve the response to FGM. The bill is part of our wider work through the implementation of our national action plan on ending FGM, which focuses on prevention, protection from harm and the provision of services for women and girls. I hope that the bill will attract the support of members right across the chamber.

## Scottish Parliament Oral Answers

### European Elections (Results)

**George Adam (SNP):** To ask the Scottish Government what its response is to the results of the European elections. (S5T-01676)

**Reply from the Cabinet Secretary for Culture, Tourism and External Affairs (Fiona Hyslop):** The Scottish Government welcomes the results of the European Parliament elections ... The elections have confirmed that there is overwhelming support in Scotland for remaining in the European Union. It is clear that the results from across the United Kingdom tell a tale of two countries that have different political views, values and visions for the future. ...

**George Adam:** The cabinet secretary will be aware of the shocking reports of EU citizens in Scotland and the rest of the UK being denied their votes on polling day. What pressure has the Scottish Government put on the UK Government to investigate that scandal? ...

**Reply from Fiona Hyslop:** Participation in the European Parliament elections in whichever member state they have chosen to live in is a fundamental right of all EU citizens. The Scottish Government is therefore deeply concerned about the difficulties that were encountered by some EU citizens who were denied their right to vote. It is important that we understand that their experience was different in different parts of the country. However, Mr Adam is absolutely right. That challenge had been foreseen and the UK Government could—and should—have done something to ensure that no EU citizens were disadvantaged in exercising their fundamental rights. The Scottish Government has written to the UK Government to call for a full investigation and will share any response with this Parliament at the appropriate time. ...

**Patrick Harvie (Green):** Is the Scottish Government still committed to legislation that would ensure that the right to vote is based on residence and not citizenship? It seems to me that that is one of the most important things that we can do to address the concerns that Mr Adams raised and which I share about EU citizens being disenfranchised. ...

**Reply from Fiona Hyslop:** Patrick Harvie is right to raise that fundamental issue. I talked about the rights of citizens, and the legislation that we plan to bring forward recognises the importance of residence in relation to the franchise. I reiterate that it is important that we gather information about different experiences, particularly in different parts of the country—I know that my own council area did not have the same issues that there were elsewhere. That underlines the fact that the issue could, and should, have been tackled, and that it is a disgrace and a scandal that many of our fellow citizens here in Scotland were not able to exercise their fundamental rights.

### European Union Elections (Disenfranchisement of EU Nationals)

**Gail Ross (SNP):** To ask the First Minister what actions the Scottish Government is taking to investigate the disenfranchisement of EU nationals who were denied their vote at the recent EU elections. (S5F-03383)

**Reply from the First Minister (Nicola Sturgeon):** The number of EU nationals who appear to have been denied the vote in the European elections last week is nothing short of disgraceful. They are people who live and work here, and this is their home. They had as much right to vote as any of the rest of us had. The issues that arose were clearly a result of insufficient preparation time because of the

prevarication over Brexit and a failure to address concerns that were raised by the Electoral Commission following the European elections in 2014. The fact that the United Kingdom Government appears to have taken no action to address the matter is unacceptable.

The Cabinet Secretary for Government Business and Constitutional Relations wrote to the UK Government in advance of the election warning that this could happen, and he has now written again, calling for a full investigation into the issue to take place.

**Gail Ross:** In yesterday's statement, the cabinet secretary said that the proposed franchise for any future referendum would rightly include EU citizens and 16 and 17-year-olds. To save confusion or mistakes reoccurring, surely that must be the standard for all elections. Will the First Minister therefore continue to press the UK Government to adopt that system at Westminster or, even better, put full control for holding democratic votes in the hands of this Parliament?

**Reply from the First Minister:** I certainly agree that we should do the latter but, short of that, I think that 16 and 17-year-olds and EU nationals should have the right to vote in all elections in Scotland. As Mike Russell said yesterday, and as will be covered in separate legislation, we want to extend the right to vote to anybody who is legally resident in this country, regardless of which country they come from. I think that that is fair and a sign of the open, inclusive and progressive country that we want to be. We will continue to press the UK Government on those matters. We should not lose sight of what happened last week. I will not be the only one who spoke to people at polling stations who had been denied their right to vote. I spoke to one constituent who was almost in tears and who felt that this was the final straw with all the stress and anxiety that he has gone through over the past three years. There should be an investigation into the issue, and any necessary steps should be taken to ensure that this disgrace is never allowed to happen again.

**Christine Grahame (SNP):** I, like many members in the chamber, have constituents who were denied the right to vote, despite having filled in the appropriate UC1 form. I do not have faith in the Westminster investigation. I note what the cabinet secretary has done. Would the Government also consider opening a contact point for EU citizens in Scotland to register with, if they were

**Reply from the First Minister:** We will certainly give that consideration. As Christine Grahame will be aware, we have established an advice line for EU nationals seeking to apply for the right to remain here after Brexit. It may be that we can do something similar to allow people who were denied the right to vote to register that fact, which would give us the opportunity to understand the scale of the issue. I see that Mike Russell is noting that down; I will ask him to explore that possibility and report back to Christine Grahame once we have had the opportunity to look into it.
