## Immigration and Asylum

### Scottish Parliament Written Answers: Ukraine

#### Ukraine: Super Sponsor Scheme

**Kaukab Stewart (SNP)** [S6W-10378] To ask the Scottish Government whether it will provide an update on its arrangements for welcoming displaced people from Ukraine through the Super Sponsor scheme.

**Reply from Neil Gray:** The Scottish Government's super sponsor scheme was introduced on 18 March 2022, to offer sanctuary in Scotland to displaced people from Ukraine. It works within the UK Government's Ukraine Sponsorship Scheme to provide a fast and safe alternative to private sponsorship.

Statistics published by the UK Government show that, as at 11 August, 10,056 people sponsored by the Scottish Government had travelled to Scotland. We continue to provide safe and secure temporary accommodation to all Ukrainians who need it on arrival.

This includes the MS Victoria I passenger ship, which has been docked in Edinburgh, which is providing temporary accommodation for 1,000 people from Ukraine. There has been positive reception from those families accommodated on board and from stakeholders.

There are nearly 36,000 Super Sponsor applications that have been made, of which nearly 30,000 have been approved for a visa so far. Not everyone will choose to use their visa. However, excluding the 10,000 who have already arrived so far this means around a further 20,000 visa holders could potentially arrive.

Therefore the Scottish Government has chartered a second passenger ship which will be located in Glasgow. We expect the ship to be operational in September, and it will provide up to a further 1750 people with the same level of facilities and support currently available to those in Edinburgh.

This is a humanitarian crisis requiring a whole of Scotland response, and the Scottish Government will continue to work closely with local councils and with the Convention of Scottish Local Authorities to ensure that those displaced people who are already here, and those who have applied and are granted permission to travel, will be safe, secure and supported for as long as they need, after the dangers they have faced at home.

We are getting very close to capacity for the temporary accommodation currently available, particularly across the Central Belt. We do not want people having to stay in temporary accommodation for any longer than is necessary. We are therefore putting every effort into helping people find longer-term accommodation in communities across Scotland.

#### **Ukraine: Super Sponsor Scheme**

**Alex Cole-Hamilton (Liberal Democrat)** [S6W-10153] To ask the Scottish Government whether it will provide an update on its timescale for moving Ukrainian refugees from welcome hubs into longer-term accommodation.

**Alex Cole-Hamilton (Liberal Democrat)** [S6W-10157] To ask the Scottish Government whether it can provide an update regarding the planned date for the reopening of the Super Sponsor scheme.

**Reply from Neil Gray:** When displaced people from Ukraine arrive at Scotland's Ukraine Welcome Hubs, they are given an immediate warm welcome to Scotland and immediate support in a safe and secure space. If those from Ukraine need temporary accommodation they will be placed in a hotel or similar accommodation where they can stay until they can move into longer term accommodation.

Some people may choose to rent privately, while others can use the national matching service, delivered by the Convention of Scottish Local Authorities and the Scottish Government, which will seek to match them with an appropriately sized and located Scottish household under the super sponsor scheme. This matching service is working hard to find longer-term accommodation for all those in hotels or similar temporary accommodation.

We are taking actions to accelerate matching to the levels needed to move those from Ukraine out of temporary accommodation as soon as possible, including enhancing teams to boost capacity.

The Scottish Government has committed £11.2 million to increase capacity of

resettlement teams, support refurbishment of properties, help integration and enhance the pace of checks.

### **Ukraine: Super Sponsor Scheme**

**Alex Cole-Hamilton (Liberal Democrat)** [S6W-10154] To ask the Scottish Government what (a) assessments it undertook and (b) preparations it made regarding the accommodation of refugees coming from Ukraine, prior to opening the Super Sponsor scheme.

**Reply from Neil Gray:** Due to the urgent need to respond to a humanitarian crisis, the Scottish Government undertook rapid engagement with relevant organisations prior to and immediately after taking the decision to support displaced persons from Ukraine.

To address stakeholder concerns around the speed of the UK Government's private matching scheme, as well as safeguarding issues, the Scottish Government and COSLA agreed to commit to an initial triage of 3000 displaced people from Ukraine through a Super Sponsor Scheme. This provided a fast and safe alternative to private sponsorship, meaning people could travel immediately and be provided with temporary accommodation, meals and a range of support and advice including translation, assessing medical needs (such as trauma) and applying for benefits.

The process of matching of arrivals from Ukraine has drawn on COSLA's extensive experience. Such as with the Syrian Resettlement Programme, which saw all 32 local authorities in Scotland participate and welcome over 3,300 refugees into their communities.

The Scottish Government's Super Sponsor Scheme has now offered sanctuary to over 10,000 displaced people from Ukraine to travel to safety in Scotland, far exceeding the original commitment and providing sanctuary for people who otherwise could not have travelled were it not for the Super Sponsor Scheme.

### **Ukraine: Refugees**

**Alex Cole-Hamilton (Liberal Democrat)** [S6W-10143] To ask the Scottish Government what arrangements it is currently making to prepare to welcome any further refugees arriving from Ukraine in the coming weeks and months.

**Reply from Neil Gray:** Scottish Governments priority is to ensure that displaced people who are already here, and those who have applied and are granted permission to travel, are able to stay in appropriate temporary accommodation and get the right support ahead of moving into safe, sustainable longer-term accommodation.

The Scottish Government has also made available £11.2 million in funding to help local authorities increase their teams to help people with temporary resettlement into communities across Scotland, and also to invest in making improvements to housing stock so that there are more homes available for Ukrainians to move into. We have also provided a further £1.3 million to the Scottish Refugee Council to enable it to increase its capacity and extend invaluable help and support to arriving Ukrainians, many of whom will have experienced significant trauma.

We are taking significant action to increase our temporary accommodation capacity as well as boosting our matching system to maximise the number of people who

can be placed with volunteer hosts who have completed the necessary safeguarding checks. We have, for example, chartered a second passenger ship, M/S Ambition, to be located in Glasgow. The ship should be fully operational in September, and it will provide up to a further 1750 people with the same level of facilities and support currently available to those on the M/S Victoria in Edinburgh.

### **Ukraine: Refugees**

**Alex Cole-Hamilton (Liberal Democrat)** [S6W-10158] To ask the Scottish Government whether it has considered a community-based model for hosting refugees from Ukraine.

**Reply from Neil Gray:** It has been heart-warming to see the groundswell of support from our communities, public services, third sector and partners for people fleeing Russia's illegal invasion of Ukraine. We have worked closely and collaboratively with partners to stand up our Warm Scots Welcome response, ensuring that all those arriving from Ukraine are accommodated and supported as soon as they arrive in Scotland. Local authority caseworkers are in place to enable access to services including healthcare, education, employment and benefits advice.

In collaboration with the Scottish Refugee Council, we have delivered three public webinar sessions for hosts. Scottish Government officials regularly engage with community groups working to support people fleeing the war in Ukraine, and those who have volunteered to host displaced people in their homes.

We are working closely with the UK Government, local authorities and other partners to ensure we are ready to welcome people to Scotland and ensure they are provided with the safety and security they need to rebuild their lives. A national matching service, delivered by COSLA and Scottish Government, is working hard to find longer-term accommodation for displaced people from Ukraine, ensuring their full integration into communities across the country.

### **Homes for Ukraine**

**Alex Cole-Hamilton (Liberal Democrat)** [S6W-10160] To ask the Scottish Government whether it will provide an update on how many people, who signed up to the Homes for Ukraine scheme, are still waiting to be vetted.

**Reply from Neil Gray:** All 32 Scottish local authorities are working to conduct the necessary person and property checks for volunteers in Scotland who, having signed up initially for the UK Government scheme, have continued to express interest in hosting displaced people. Once checks have been completed, if the offer is deemed suitable, these hosts' details are uploaded onto the national matching service database, so that displaced people can be offered the opportunity to move into their homes.

We are aware that some volunteer hosts have expressed interest but have not yet been contacted, while others are still awaiting the outcome of checks. The Scottish Government is grateful to volunteer hosts for their generosity, and their patience. We are working closely with local authorities and with the Convention of Scottish Local Authorities (COSLA), doing all we can to speed up the matching process and increase the numbers of displaced people moving into host accommodation, including enhancing teams to boost capacity.

### Ukraine: Refugees

**Alex Cole-Hamilton (Liberal Democrat) [S6W-10145]** To ask the Scottish Government whether different households are sharing rooms on board the MS Victoria, and what measures are in place to ensure (a) infection control to limit any spread of COVID-19 and other viruses and (b) the safety and security of those living on board the ship.

**Reply from Neil Gray:** Safeguarding the health of displaced people on the M/S Victoria I passenger ship is our priority, as it is in other temporary accommodation such as hotels. We are closely monitoring the spread of COVID in Scotland and we are liaising closely with Public Health colleagues to monitor any risks of contracting COVID within the passenger ship.

Displaced people from Ukraine can also ask for a free COVID-19 vaccination from the NHS after arrival, if they choose to be vaccinated.

The ship has a policy for common infectious diseases including COVID-19, with safeguards in place and crew appropriately trained. The NHS is servicing the vessel with a medic and staff throughout the week, providing medical care for both Ukrainian guests and crew. COVID-19 isolation rooms have been identified and set aside if needed, and the ship has a full protocol on board just for COVID-19, which includes self-isolation, testing and doctor well-being checks.

Doctors aboard the ship are obligated to report any cases of infectious disease to the NHS, and Tallink, the ship's operator, is also responsible for reporting COVID-19 cases that are detected by the ship's on-board team to the NHS.

There are a few cases where different households are sharing rooms aboard the ship, however only those who have chosen to do so.

Every effort will be made to ensure that guests on board have access to appropriate support services, including healthcare, and staff at temporary welcome accommodation advise displaced people on how to register with a GP.

### Ukraine: Refugees

**Alex Cole-Hamilton (Liberal Democrat) [S6W-10159]** To ask the Scottish Government what action it is taking to recruit Ukrainian speakers, who are already living in Scotland, to help welcome and communicate with refugees from Ukraine.

**Reply from Neil Gray:** When displaced people from Ukraine arrive at Scotland's Ukraine Welcome Hubs, they are given an immediate warm welcome to Scotland and immediate support in a safe and secure space. Welcome Hub staff will talk to those who have arrived about their immediate needs, including language support. Public services in Scotland – including healthcare, welfare, schools, councils and housing services – must provide individuals with a qualified interpreter if they need one. Some councils are also offering translated information on a variety of subject matters, and guests from Ukraine can discuss the availability of these with their assigned local authority caseworker.

The Scottish Refugee Council are working with the Scottish Government to deliver the Warm Scottish Welcome scheme, which includes translation and interpreting services. The Scottish Refugee Council have received funding from the Scottish Government to recruit additional advisors for their Refugee Integration Service, including Ukrainian speakers, as part of their work to deliver the Warm Scottish Welcome scheme. We recognise that translation and interpreting services for people arriving in Scotland from Ukraine are extremely important and the Scottish Refugee Council have asked that anyone wishing to offer assistance in this area contact them to discuss what support they can offer.

### **Local Authorities: Ukrainian Refugees**

**Alex Cole-Hamilton (Liberal Democrat)** [S6W-10147] To ask the Scottish government whether it plans to increase the support available to local authorities for (a) conducting disclosure checks and (b) vetting accommodation for Ukrainian refugees.

**Reply from Neil Gray:** The Scottish Government has made available £11.2 million in funding to help local authorities increase their teams to help people with temporary resettlement into communities across Scotland, and also to invest in making improvements to housing stock so that there are more homes available for Ukrainians to move into.

The Scottish Government has also published guidance for local authorities which includes what safeguarding measures, such as disclosure checks, should be in place for people arriving. This guidance can be found on the Scottish Government website:

### **Local Authorities: Ukrainian Refugees**

**Stephen Kerr (Conservative)** [S6W-10067] To ask the Scottish Government which local authorities are using the reported “surge teams” for assistance in matching Ukrainian refugees into longer-term accommodation.

**Reply from Neil Gray:** The teams are currently active in supporting Edinburgh, West Lothian and more recently Renfrewshire.

Matching activity has increased with a team deployed on board the M/S Victoria I passenger ship in Leith, with further plans in place to deploy support in Aberdeen later this week.

Teams will continue to work in partnership with our local authority partners to consider how best we can respond to areas where there is a need for increased matching activity; including where there is a need to prioritise matching activity in hotels where temporary accommodation arrangements are coming to an end.

**Reply from Neil Gray:** Scotland’s response to the crisis in Ukraine is a round-the-clock operation, supported by multi-agency teams, local authorities, CoSLA and the third sector to ensure individuals displaced from Ukraine are treated with care and respect and their complex needs are met.

Scottish Government continue to benefit from a good working relationship with local authorities where we are, jointly with COSLA, providing additional matching resource to support local authority activity. Feedback to date from local authorities and other partners regarding the use of matching teams has been positive.

### **Local Authorities: Ukrainian Refugees**

**Stephen Kerr (Conservative)** [S6W-10069] To ask the Scottish Government what level of support it expects local authorities to provide to Ukrainian refugees housed in temporary accommodation.

**Reply from Neil Gray:** Local authorities play a vital role in the success of the Scottish Government's Super Sponsor Scheme. They are uniquely placed to provide the support required to ensure those arriving are given the warmest possible welcome. This includes working with displaced people to identify and meet immediate and longer term needs. This will see displaced people registered with GP and school, provision of local information on services and area, advice and support to access benefits, receipt of initial financial support if required until benefits are accessed and paid, and advice and support on accessing further/higher education.

## Scottish Parliament Written Answers: Other Immigration and Asylum

### **New Scots Refugee Integration Delivery Project: Arabic Speakers**

**Donald Cameron (Conservative)** [S6W-09929] To ask the Scottish Government how many Arabic speakers in (a) Dundee, (b) Fife and (c) Clackmannanshire it has helped access certification to work in the Scottish construction industry through its New Scots Refugee Integration Delivery Project since August 2021.

**Reply from Shona Robison:** Many refugees resettled in Scotland have skills and experience developed through their trade or occupation in their home country, including in the construction industry, and may want to resume their profession here.

In Scotland, everyone working on a building site must first pass a health and safety test and be certified through the UK wide Construction Skills Certification Scheme (CSCS).

The Building Skills for Construction Certification Project has developed supporting ESOL materials, to help ESOL learners to prepare for the computer CSCS test. Pilot courses are being delivered to test the resources. The project started on 1 September 2021 and will run until 30 November 2022. Pilot courses are running in Fife, Clackmannanshire and Dundee, as well as a national online pilot for candidates across Scotland to enable those who cannot access such training in person to benefit, particularly those in remote and rural communities where a pilot course would not be viable due to numbers.

There are seven Arabic speakers enrolled in this course across Dundee, Fife and Clackmannanshire. Throughout the rest of Scotland there are an additional thirteen learners on these courses, eleven of whom are Arabic speakers.

The CSCS ESOL course resources will be a lasting legacy of the project. At the end of the project, these resources will be freely available for any learning provider or training organisation to use, allowing courses to be run across Scotland to prepare refugees for work in the construction industry. There will also be a webinar at the end of the project which will cover how these resources should be used in practice. This project has been funded through the New Scots Refugee Integration Delivery Project which is part funded through the EU Asylum, Migration and Integration Fund.

## Asylum and Detention System

**Pauline McNeill (Labour)** [S6W-09584] To ask the Scottish Government what its position is on whether a system could be introduced to monitor the impact on people's welfare of the operation of the asylum and detention system in Scotland.

**Reply from Shona Robison:** Asylum and immigration are matters reserved to the UK Parliament. This includes the operation of the UK asylum system and immigration detention. An effective system to monitor the impact of the asylum system or immigration detention on people's wellbeing would require access to personal data and information about people seeking asylum or in immigration detention. This data is held by the Home Office, and the Scottish Government does not have access to it. Many third sector organisations have direct knowledge of the negative impact the asylum system can have on people's welfare, through their work supporting people within communities. The complexity of the asylum system, the low level of support provided by the Home Office and the continuing uncertainty of waiting for a decision are often combined with previous trauma and vulnerabilities. Evidence from the third sector, and people with lived experience, indicates that the asylum process itself can be re-traumatising.

## Racism, Religious Hatred, and Discrimination

### Scottish Parliament Motion

**Kaukab Stewart (SNP) [S6M-05615] Changing the Boundaries – Ending Institutional Racism in Sport** – That the Parliament notes with concern that the report, *Changing the Boundaries: The Plan4Sport Independent Review into Racism in Scottish Cricket*, found Cricket Scotland to be institutionally racist; understands that the review identified 448 examples demonstrating institutional racism; further notes Sir William MacPherson's definition of institutional racism contained in the 1999 report of the public inquiry into the death of Stephen Lawrence, as "the collective failure of an organisation to provide an appropriate and professional service to people because of their colour, culture or ethnic origin"; acknowledges that institutional racism in sport may not be restricted to Cricket Scotland; recognises what it sees as the detrimental effect of institutional racism on an individual's potential, achievement, health and wellbeing; notes the hope that the implementation of the immediate and long-term recommendations of the independent review will deliver substantial improvements in the experience of people of colour in all sports; further notes the recommendation to improve the diversity of the Cricket Scotland board, and the view that this recommendation, coupled with steps to review diversity at all levels of decision making, can be of great importance in delivering diversity in boards and at all levels of decision making across all sports; notes the view that effective equalities and anti-racist strategies are important in organisations that are in receipt of government

funding; welcomes the assessment framework set out in the report; notes the view that this could be used as a conditional part of funding criteria for all funding of sport in Scotland; highlights that ethnically diverse communities are a priority group for sportscotland's 2021-25 Equality Outcomes published in 2022; believes that there are many examples of clubs and individuals delivering local programmes that engage with diverse communities, including in the Glasgow Kelvin constituency; appreciates what it sees as the important work being done by groups including, but not limited to, Show Racism the Red Card, Kick it Out, Running Out Racism; notes the calls for partnership working to eradicate any forms of racism in sport, and looks forward to the day when zero tolerance for any processes, attitudes and behaviour that amount to racial discrimination, through the exclusion of minority ethnic people from participation and talent development opportunities, becomes a reality in Scottish sport.
